Nav Srishti has Collaborated with the Bosch BRIDGE skill development program and started our first training batch in Neb Sarai and Faridabad today. Twenty-five boys and girls will receive professional training for 3 months, after which they will be placed in the retail, hospitality, and automobile sectors.
