# Programs

## Looking Back at the Year

---



# EARLY CHILDHOOD DEVELOPMENT



Children under 6 years old participate in our Early Childhood Development initiatives through crèche and ICDS Anganwadi interventions. They acquire the knowledge, behaviors, and skills necessary to build relationships, learn, function effectively and independently, and adapt to changes in their environment.

## Key Achievements



Facilitated the enrolment of 177 children under six years in crèches, government run National Creche (monitoring by National Creche Intervention ) and pre-schools, ensuring early childhood care, nutrition, and foundational learning.



Conducted 20 doctor visits, ensuring regular health check-ups and medical support for children and the community. Facilitated the recovery of 16 malnourished children, helping them transition to a healthy state through proper nutrition, healthcare, and continuous monitoring.



Held 20 parent meetings during the project, promoting awareness, engagement, and collaboration in children's education, health, and well-being, strengthening parental involvement for better development and support.



Facilitated the successful transition of 28 children into formal schooling, ensuring their access to education and a brighter future.

## Godrej Nest



We operate two crèches at construction sites in Noida, Uttar Pradesh, catering to children of working construction laborers. These crèches serve children aged 0-12 years, providing a safe environment where working mothers can leave their children without worry. The program offers supplementary nutrition, hygiene, healthcare, and early education. A total of 80 children benefit from these centers, which are divided into three categories: crèche for children under 3 years, Balwadi for children under 6 years, and non-formal education for children above 6 years.

## Child Care Development



We provide crèche facilities for 97 children aged 0-6 years at two centers in Neb Sarai, Delhi, catering to families where both parents are daily wage earners. Many of these families have migrated from other states and lack support networks or safe spaces for their children. The crèches offer nutritious meals, growth monitoring, doctor checkups, and activity-based early developmental learning. We also conduct parent meetings, community awareness programs, and other sessions to educate parents and encourage their involvement and responsibility.

## Case Study



Child's Name – Sanjana

Gender – Female

Age of child during enrolment – 3 years

Mother's Name – Usha

Father's Name – Chandu

When Sanjana was enrolled in the center, she was very weak and frequently sick. We had her checked by a doctor. She had little appetite, and when she did eat, it was very little. Her digestion was poor, and she would vomit after eating. She also experienced frequent stomach aches. After the doctor examined her, he prescribed deworming medication. With the timely administration of the medication, there was a positive impact on her health. When we measured her weight, we noticed an improvement. Initially, her weight was 9.5 kg, and after six months in the creche, her weight had increased to 12.5 kg.

*Since 1999, we have been running two crèches for 50 children of working and ailing mothers with the support of the Ministry of Women & Child Development. In 2015, with the help of Mobile Crèches, we expanded our efforts to provide crèches at construction sites in Haryana and Uttar Pradesh.*

*However, in 2023 and 2024, the government shut down NGO-run crèches, affecting our two centers as well. We are deeply grateful to Mobile Crèches and the Chirag Foundation for stepping forward to support these crèches, ensuring that 50 children continue to receive care. Their support has also spared many working mothers from the distress of leaving their jobs.*



# CHILD PROTECTION



Child protection is a very sensitive issue, especially the protection of children in today's scenario. Children are not even safe in their own homes, and parents often struggle to accept this fact. We have been working at the grassroots level, spreading awareness about child protection and child rights issues among the general public, including men, women, and children.

## Key Achievements



Mental health sessions at BK Hospital, Faridabad, reached 162 children and conducted screenings. Five children required further care, and as a support organization, we facilitated their treatment at BK Hospital.



The Missing Children Campaign educated 5,250 people on child safety, established 12 vigilant groups, and trained 50 individual whistleblowers to strengthen local child protection efforts and prevent exploitation and disappearances.



A 15-day World Against Child Labor Day was celebrated in Nangloi, Delhi, and Faridabad engaged 6,000 people in awareness activities. With DCPU's support, 32 children were rescued from child labor and begging and presented before the CWC.



An interface meeting on missing children brought together 30 stakeholders and community leaders to discuss prevention, recovery, and support strategies. Additionally, 95 police personnel (80 males, 15 females) were trained on the Standard Operating Procedure for missing children.

## Missing Children Campaign



A total of 5,250 people were made aware of the prevention of missing children through the Missing Children Campaign. Every Friday, the Nav Srishti team distributed pamphlets, conducted 5 street plays, and held interface meetings with 30 stakeholders, including DCPU, DLSA, AHTU, CWC, DCWO, and community leaders. Additionally, sensitization sessions on the SOP for missing children were conducted for 95 police personnel in Haryana and Delhi.

## Mission Vatsalya



On 27th September 2023, a one-day workshop on Mission Vatsalya was organized, where in-depth information was provided to 30 community leaders about Mission Vatsalya, the formation of Child Protection Committees at the ward level, and the establishment of Child Protection Committees at the district level.

## Legal Awareness Campaign



On 22nd September 2023, a Legal Awareness Camp was organized at Sarai Khawaja Senior Secondary School. During the camp, information was provided about 'Good Touch, Bad Touch,' the POCSO Act, Child Rights, the Child Helpline, and the emergency helpline number (dial 112).



## Vigilance Groups



12 vigilance groups, consisting of 322 members, formed in Delhi and Faridabad have developed a protection network to create a community-based child protection mechanism. The groups consist of members from the same community, representing different professions, to ensure child protection through prevention and redressal.

## Case Study

On 9th July 2023, a vigilance group member reported to Childline that a 15-year-old girl had been missing since midnight. Childline promptly followed up with the Investigation Officer (IO), with continued vigilance from the group. On 11th July, the IO informed Childline that the girl had contacted her father and that the police had traced her phone. The case was formally registered, and on 19th August, the Sarai Khawaja police traveled to Ludhiana, successfully locating and bringing the girl back to Faridabad. She was presented in court, where her statement was recorded under Section 164 of the CrPC. Following the court's order, the girl was reunited with her father. The police also charged a boy under the POCSO Act, and he was sent to jail.

*Nav Srishti's relentless 30-year journey has been successful, thanks to the unwavering support of Child Rights and You (CRY) since 1998. For the past 26 years, CRY has been our first and longest-term donor, playing a crucial role in developing our professional skills. With CRY's support, we have secured funding from approximately 60 national, international, CSR, and government sources, enabling our growth and expansion. We extend our heartfelt gratitude to CRY for being an integral part of our journey.*

# INCLUSIVE AND QUALITY EDUCATION



We ensure that all children have access to quality education, from pre-primary to senior secondary levels, and are empowered to make informed career choices. Through our various interventions, we have enabled children, particularly girls, to enroll, stay in school, and successfully complete their education. We have also strengthened the School Management Committees to achieve the goals of our Inclusive and Quality Education programme.

## Key Achievements



Provided supportive classes in English, Mathematics, and Science to 315 children, strengthening their foundational learning and improving academic performance.



Enabled 90 children to access digital learning infrastructure in classrooms, enhancing their learning experience and improving educational outcomes through technology-driven education. Additionally, 15 youths secured jobs after completing their training.



Provided career guidance and counselling to 105 children, helping them explore career options, set educational goals, and make informed decisions about their future.



Back to school campaign 1800 people made aware and total admission in school dropout and never been 46. Among them 10 girls admitted at NOS for Secondary education.

## Child Rights & Education Program



We are running Child Activity Centres in the Gosai Community in Nangloi (West District), Sultanpuri (North West District) of Delhi, and Santosh Nagar in Faridabad, where 200 children receive remedial classes in English, Maths, and Science through play-based methods to improve their foundational learning.

## Digital Learning Centres



90 children have access to digital learning infrastructure in classrooms, aimed at improving learning outcomes. They are also affiliated with the NIIT certification course, covering both basic and advanced computer courses, at two Digital Learning Centres in Nangloi (Delhi) and Faridabad (Haryana).

## Life Skill Education Program



Life Skills education provides career counseling and guidance to disadvantaged girls and boys between the ages of 15 and 24, helping them break unconscious biases and stereotypes that impact their education and career choices. The project reached out to over 250 youth program participants in Delhi and Faridabad (Haryana) through career counseling and community interactions.

## Case Study



In April-May 2023, an organization identified 10 school dropout girls, aged 12-13 years out of education, due to poor financial conditions. Their parents, mainly daily laborers, struggled to support their education. Among them, 3 were single-parent children, and 3 lived in rented homes. The organization enrolled these girls in 10th grade under NIOS in July, provided daily classes at a child activity center, and facilitated a computer course at a DLC center. In April-May 2024, all girls passed their exams in the first division, scoring 70-75%. Currently, 4 are pursuing higher studies, and 6 are employed.

*In the Santosh Nagar slum, where we have been working since 2015, a meeting with children revealed a concerning issue. They shared that they found it difficult to focus on their studies due to constant fear caused by domestic violence at home.*

*Realizing the impact of this violence on children's education and overall development, we came up with the idea of forming a Mahila Panchayat within the slum itself. We introduced the concept to local women and provided them with training. Over time, women in the community began addressing and resolving cases of domestic violence.*

*The impact soon became evident. Children reported a reduction in violent incidents, and some women acknowledged that since the Panchayat began working—engaging in discussions with both husbands and wives—cases of domestic violence were being reported and addressed, leading to a significant decline in physical abuse. As a result, children can now focus on their studies, improving their overall academic performance.*



## SKILL DEVELOPMENT



We have implemented projects focused on job-oriented vocational training and entrepreneurship promotion. We worked closely with employers, thereby increasing women's participation in the workforce. Our focus has been on supporting young women and men to build skills for new economy jobs such as IT-enabled services, retail marketing, and hospitality.

We also extend activities aimed at improving livelihoods, generating income, and promoting women-owned enterprises. We have assisted women in establishing and expanding microenterprises, accessing finance, markets, and networks, and generating employment opportunities.

### Key Achievements



Empowered 253 women through Retail skill training, enabling them to secure jobs or start their own micro-enterprises, with an average monthly income of INR 12,000 to 18000/-



Trained unemployed women in tailoring and beauty services, equipping them with sewing machines and enabling them to earn an average monthly income of INR 5,000.



Nav Srishti empowers both literate and illiterate women by forming cooperatives to enhance their livelihood opportunities. One such group of 10 women successfully started a catering service, enabling each member to earn between ₹5,000 to ₹7,000 per month, fostering financial independence and self-reliance.

## TRRAIN HER ASCENT



The TRRAIN HER ASCENT course is a comprehensive 35-day program designed to equip trainees with essential professional skills and in-depth knowledge of the retail sector. We have conducted training for 4 batches, each consisting of 25 girls. The course is conducted through full-day sessions led by our experienced trainers, with the curriculum covering key concepts and providing trainees with hands-on experience. Upon successful completion of the course, they take a final assessment, after which they are awarded certificates and placed in relevant job roles.

## Computer Training



We operate a Digital Learning Center in Nangloi, where we've conducted 60 sessions covering various digital education topics, including computer basics, text editing and formatting, MS Word, Excel, online search engines, email, Skype, resume creation, and online banking. We follow the NIIT syllabus, empowering students to work on projects related to these subjects.

## Tailoring



Every year, we select two batches for our six-month stitching and tailoring course. Participants undergo training, and their progress is assessed through monthly evaluations by their trainers. Singer India Limited also conducts a final evaluation test. This year, a total of 96 beneficiaries enrolled in the training program. Notably, 28 of these individuals received certificates upon successfully completing the 6-month course. These certificates are awarded as a testament to our commitment to empowering women through skill development, which leads to improved livelihoods and a brighter future.

## Beauty Culture



Nav Srishti has been providing training in beauty parlor skills, empowering women to pursue various career paths in the beauty industry. Many trainees aspire to open their own parlors, some aim to offer door-to-door beauty services, and others hope to secure jobs in salons. All 30 participants have completed the basic course and are now enrolled in an advanced course. Upon completion, they will be well-prepared to earn independently by starting their own ventures or working in salons.

## Case Study



Anisha, a 22-year-old, joined the TRRAIN HER ASCENT COURSE at Nav Srishti with the goal of fulfilling her parents' dream of seeing her in a respectable job. Due to financial constraints, she had faced challenges in developing her personality and professional skills. The training at Nav Srishti provided her with the opportunity to enhance her communication skills and become job-ready. Through the course, she gained valuable insights into customer interaction during an exposure visit, which further boosted her confidence and ability to connect with clients. As a result of her hard work and newfound skills, Anisha secured a position as a sales executive at Senco Gold on March 19, 2024, with a monthly salary of ₹15,000. This job marks a significant step in her career, allowing her to contribute to her family's aspirations while building a successful professional future.

# GENDER BASED VIOLENCE



We safeguard the rights of girls and women from disadvantaged families, protecting them from all forms of violence, abuse, exploitation, and neglect. Gender-based violence (GBV) is defined as any act that causes physical, sexual, or emotional harm and reinforces gender inequality. Women are disproportionately affected by GBV (although it also impacts men and boys), yet women's rights issues remain significantly underfunded, with the majority of aid still reaching men. GBV is a global issue that affects hundreds of millions of people, with particular implications for those who hold marginalized racial, ethnic, class, or disabled status.

## Key Achievements



Supported 3,411 women through the Women Helpline in North Outer Delhi, ensuring safety and guidance. Provided counseling to 2,014 rape survivors via the Crisis Intervention Centre in Outer and North Outer Delhi, aiding their recovery and empowerment.



Provided counselling to 889 women on family disputes, domestic violence, and abuse, helping them navigate challenges and seek solutions for a safer future.



Resolved 85 gender-based violence cases through Mahila Panchayat, offering counseling and support. Strengthened 250 community women in Sangam Vihar for resilience building, enabling them to form solidarity groups and advocate for women's rights and safety.

## Women Helpline



The "Mobile Help-Line (MHL)" project, operational since December 2013 with support from the Delhi Commission for Women, provides immediate support to victims of domestic violence and atrocities against women. A dedicated team of six offers round-the-clock assistance across seven police station areas in North West Delhi, serving an estimated 15 lakh people. This year, MHL handled 3,411 cases, made 1,962 site visits, and followed up on 1,886 cases to provide continued support, counseling, and shelter.

## Family Counselling Centres



The program supports women facing issues like domestic violence, dowry, sexual harassment, divorce, and family disputes through a structured process. It involves understanding the complaint, obtaining a written statement, notifying the second party, and facilitating discussions and counseling to resolve the issue. Unresolved cases are referred to authorities like the Family Court, DCW, or DLSA.

## Crises Intervention Cell



The Crisis Intervention Cell (CIC) aids rape survivors in the Outer and Outer North districts with case registration, trauma recovery, and rights awareness. With six counselors covering 18 police stations, the CIC operates 24/7, responding to DCW helpline and police calls. It provides legal aid, medical support, and compensation, with counselors undergoing regular training. During this period, the CIC handled 25 FIR cases, assisted 542 survivors, and followed up on 1,255 cases.

## Mahila Panchayat



Two Mahila Panchayats in Nangloi and Faridabad, consisting of 50 dedicated women volunteers, play a vital role in resolving women-centric disputes within the community. Throughout the year, they organized 28 meetings, providing a platform for women to raise grievances and seek solutions outside of the legal system. Of the 26 cases handled, 19 were related to domestic violence, reflecting its prevalence. The Panchayat successfully resolved 17 cases through mutual agreements, while the remaining 9 were referred to the courts, demonstrating their commitment to community-based dispute resolution and justice.

## Women's Day Celebration



We celebrated International Women's Day with our Nav Srishti team members, adolescent girls, women, and a group of senior citizens. International Women's Day focuses on issues such as gender equality, violence, and abuse against women.



# HEALTH



The program improves health among Delhi's transport sector workers, especially truckers and their families, by providing primary healthcare and raising awareness about HIV, diseases, hygiene, sanitation, and nutrition. It promotes behavior change, access to quality healthcare, and referral systems to public and private facilities, leveraging experience from addressing health disparities in Rajasthan.

## Key Achievements



Provided healthcare services to 37,477 direct beneficiaries through mobile health clinics, ensuring improved medical access for underserved communities and enhancing overall well-being through timely interventions and essential care.



We provided essential health services to 452 truckers and 848 allied workers, offering HIV and diabetes testing along with vision screening, promoting early detection and better health outcomes.



Out of 460 beneficiaries screened, 43 were diagnosed with cataracts, and 12 underwent free cataract surgeries, restoring their vision and improving their quality of life.



The health camp conducted comprehensive screenings, including clinical breast exams for 93 participants, PAP smear tests for 44 individuals, and oral, blood pressure, and sugar tests for 103 people, promoting early detection and preventive cancer care.

## Health Care Express – Delhi MMU



Under the Apollo Tyre Health Care Express (Delhi MMU Project), "Sakushal Sarthi" health camps were held in Gurugram, Manesar, and Faridabad, providing treatment, HIV and diabetes testing, and vision screening to 452 truckers and 848 allied workers, with a total outreach of 37,477 for the year. Another camp in Nitcogali raised awareness about HIV, TB, diabetes, hypertension, and vision care, benefiting 22 truckers and 72 allied workers.

## ROSHNI



Nav Srishti, with support from Tower Vision, organized four eye screening camps in Jodhpur, Rajasthan, under a CSR initiative in March 2024. Out of 460 beneficiaries screened, 43 were diagnosed with cataracts, and 12 received free cataract surgeries, improving eye health and access to affordable care in the community.

## Screening Of Cancer



On February 28, 2024, we organized a health camp focused on cervical cancer screening, supported by the Rajiv Gandhi Cancer Hospital and Ekohum Foundation, in collaboration with the All India Women's Conference. The camp offered various health checks, including clinical breast examinations for 93 participants, PAP smear tests for cervical cancer for 44 individuals, clinical oral examinations for 103 attendees, and blood pressure and sugar tests for 103 people.

# WASH INITIATIVES



Delhi struggles with waste management due to inadequate infrastructure, poor segregation, and inefficient collection, impacting the health and safety of its 20 million residents. To tackle this, the "Zero Waste" model under the Clean My City program at Sanjay Gandhi Transport Nagar emphasizes efficient waste collection, segregation, disposal, and advocacy for WASH infrastructure development.

## Key Achievements



Transport Nagar has achieved 84% coverage in garbage collection and sweeping, enhancing cleanliness. With 1,345 collection points across households and businesses, waste management efficiency and sanitation services have significantly improved in the area.



An average of 46,145 kg of waste is collected monthly, with 3,755.5 kg biodegradable and 42,389.5 kg non-biodegradable. This consistent collection supports waste management and promotes sustainability by separating recyclable from non-recyclable materials.



An average of Rs 1,34,850 is collected monthly through community contributions, reflecting strong community involvement and efficient fund allocation to support local development initiatives and essential services in the area.



An average of 1,875 kg of manure is produced per month through composting, contributing to sustainable waste management and enriching the local environment.

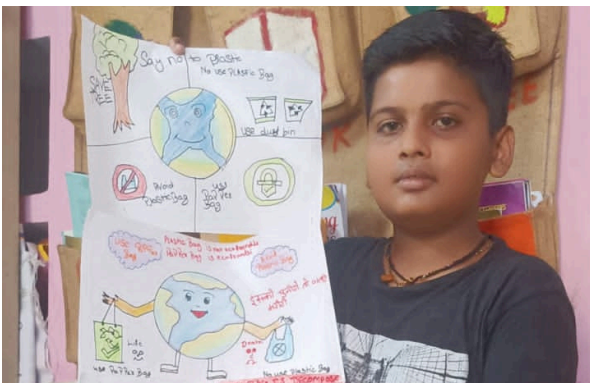


## Clean My Transport Nagar-Waste Management



The project is named Clean My Transport Nagar (CMTN). The primary objective of this initiative is to revitalize the area by implementing comprehensive cleaning measures and fostering an eco-friendly environment. With the dedicated efforts of approximately 18 skilled personnel, we aim to significantly enhance the quality of life in Sanjay Gandhi Transport Nagar.

## Say No to Plastic Campaign (Children Group)



The 'Say No to Plastic' campaign, led by the children of CAC Nangloi, aimed at raising awareness about the harmful impacts of plastic on the environment and promoting sustainable alternatives. The children created posters, drawings, and other messages highlighting the importance of saying no to plastic. They displayed these posters and drawings on the walls near the shops.

## Advocating for Sewer Cleaning and Maintenance (Adolescent Group Initiative)



Through meetings and complaints, the issues in the Nangloi area were addressed. The youth gathered signatures from community members, friends, and family to demonstrate widespread support. The letter was given to the ward member of the area, who was also requested to make the street concrete. Within two days, the MCD staff cleaned the sewer, and the ward member promised the youth that they were working on the issue. The youth remained persistent, continuing to advocate for the cause and regularly following up.



## HUMANITARIAN SUPPORT



A total of 1,255 kits were distributed to flood-affected families in several areas of Delhi NCR, including Maharana Pratap Shiv Colony, Khatu Shyam Colony, and multiple villages. These vital relief materials for children in Delhi's flood zones were identified through a survey by the Alliance for Peoples Rights (APR). Nav Srishti distributed 1,176 kits, which contained Ready-to-Eat food, sanitary supplies, bedsheets, and mosquito nets for families in need.





# All India Women Conference



Nav Srishti, a women-centric organization, has been an affiliated branch of the South East Women's Association (SEDWA) since 2010. This affiliation was granted under the leadership of the late Dr. Manorama Baba, who was the President of SEDWA at the time. Since 2023, Nav Srishti has been implementing programs in collaboration with the All India Women's Conference (AIWC).

## Key Achievements



Under the Old Age Care Program, 18 women have joined, improving their health-seeking behavior. They visit Nav Srishti regularly, engaging in cultural programs that foster inclusivity.



Under the Udaan program, 25 women were trained in stitching and awarded certificates by the All India Women's Conference. The President and Secretary personally presented the certificates. Today, 50% of these women earn a livelihood through their skills.



As part of the awareness initiative, approximately 500 women were educated on social and legal issues. This knowledge empowered them to take action, leading to an increase in women reporting their own issues and referring survivors for support and counseling.

## Old Age Care



We have started an old age daycare program for women with the support of the All India Women's Conference (AIWC). We also organized a bhajan-pooja and informed them about the old age daycare program. It is a great satisfaction to have a variety of age groups under one roof, including toddlers, adolescents, women, and now our respected senior citizens too.

## Eye Checkup Camp



An eye checkup camp was organized in collaboration with Serve Samman NGO for the entire community. A total of 198 patients benefited, including 8 who were afflicted with cataracts. Of these, 38 received eyeglasses, and 44 received medicine.

## Awareness on Missing Children & Trafficking



We organized an Awareness Session on Missing Children & Trafficking in Neb Sarai, with support from the All India Women Conference. The Faridabad Nukkad Natak Team performed a play highlighting safety measures to prevent child abductions and informed the community about helpline numbers and reporting procedures. Participants discussed topics like safety, helplines, and how to help missing children. They also identified the need for street lights, CCTV cameras, street guards, and safe playgrounds, and decided to form vigilance groups in Neb Sarai.

# At a Glance

---



On 16th and 17th June 2023, the Girls Count Coalition and Swechha India organized a regional consultation in Lucknow at the Paradise Hotel. The focus of this two-day workshop was on addressing the pressing issues of Gender-Based Sex Selection and the implementation of the PCPNDT Act (Pre-Conception and Pre-Natal Diagnostic Techniques Act). The main objective was to strengthen the capacity of community-based organizations (CBOs), enabling them to effectively utilize the PCPNDT Act in tackling the challenges of son preference, daughter neglect, and the declining number of girls born in certain regions.

Mr. Pradeep Kumar, representing Nav Srishti, attended the consultation, joining other participants to explore strategies and best practices to combat gender-based discrimination and ensure the Act's effective enforcement. The consultation aimed to equip local organizations with the necessary tools to advocate for gender equality, monitor the use of diagnostic technologies, and promote the survival of the girl child across different districts.

---



On 10th August 2023, the Rotary Club of Delhi Midwest and Humanity Infinite Foundation visited Nav Srishti and launched a year-long project aimed at supporting the girls of Neb Sarai by providing them with sanitary pads. This initiative was designed to improve menstrual hygiene and promote the well-being of young girls in the community.

The project was officially inaugurated with the distribution of 150 sanitary pads, which marked the beginning of a sustained effort to ensure that the girls in Neb Sarai have access to proper menstrual hygiene products. Along with the distribution, an important awareness session was held to educate the girls about the importance of using sanitary pads during their menstrual cycle. The session emphasized the health benefits of using sanitary pads, including reducing the risk of infections and promoting dignity and comfort during menstruation.

On 16th August 2023, in collaboration with the District Child Protection Unit (DCPU) Faridabad, Nav Srishti organized a camp at Santosh Nagar Primary School aimed at assisting children aged 0 to 18 years in obtaining essential documents like Aadhaar cards, Family IDs, and Birth Certificates. These documents are crucial for accessing various government services and ensuring the children's rights are properly documented.

The camp saw the active participation of several important government departments, including the Labor Department, MCF Department, Health Department, Education Department, and Child Line. Their involvement ensured a comprehensive approach to addressing the needs of the children, from documentation to health and education services.

Notable dignitaries such as DCPO Officer Garima, the ADC District Magistrate, and all the Anganwadi workers also took part in the camp, showing strong administrative support for the initiative. Their participation helped ensure that the event was successful in reaching a large number of children and families, providing them with the necessary resources to ensure their official documentation was in place. This initiative was a step toward enhancing the well-being of children in the community, ensuring they have the proper identification and documentation for accessing key services and opportunities.

Every day from Delhi 17-18 children go missing and out of them 6-7 children never found. Maximum children of migrant labour are missing. Irony for these children is that they have no safe place to stay when they are alone. You can support our crèche program minimum of Rs. 1000/- per month for a child.
